

Online Safety Law Trends



- ✓ Expanded definition of "child" to <16 or <18
- ✓ Age reporting (actual knowledge) or age assurance
- ✓ Opt-in consent (or ban) on targeted advertising, sales, profiling.
- ✓ Age-appropriate design
 - Privacy-protective default settings
 - User interface design (avoid dark patterns and prevent "addiction")
 - Avoid heightened risk of harm to minors
- ✓ Data minimization and limits on secondary use

Federal Activities



LEGISLATION

GUARD Act (S. 3062)

- Broad definition of AI Companion
- Bans AI chatbots for minors requiring broad age verification for all users
- Criminalizes AI that solicits or produces sexual content for minors.

CHAT Act (S. 2714)

 Requires age verification, parental consent for a minor to access chatbot SUBCOMMITTEE ON CRIME AND COUNTERTERRORISM

State Legislative Updates



California

SB 243 regulates "companion chatbots" requiring disclosure, safety protocols, and reports to state authorities.

Illinois

WOPR Act places significant limits on Al usage in mental health counseling.

Maine

Chatbot Disclosure Act establishes transparency requirements for chatbots used in trade and commerce.

Nevada

AB 406 regulates the use of AI in mental and behavioral healthcare.

New York

Enacted as part of the state budget (S-3008C), requires platforms to remind users they are not interacting with a human and identify when the user expresses thoughts of suicide or self-harm.

Utah

HB 452 establishes rules and transparency requirements for suppliers of AI mental health chatbots.

Top Risk Categories Identified:

- Misleading and deceptive advertising
- Deceptive influencer/endorser practices
- Privacy invasions / data protection risks
- Bias and discrimination in use of AI
- Harms to mental health and development
- Manipulation and over-commercialization
- Exposure to harmful content
- Lack of transparency

Mitigating Risks in Child-Directed Al Products



Core Compliance Mitigations:

- Embed privacy-by-design and obtain verifiable parental consent
- Implement human-in-the-loop oversight for AI outputs
- Use clear disclosures and AI explainability tools
- Restrict behavioral targeting and disable nudging techniques
- Apply robust moderation for AI and user-generated content

Corporate Governance:

- Vet third-party vendors and data practices
- Establish AI "Greenlight" or ethics review committees
- Conduct bias impact assessments
